#### **Education after BHS:**

While in school, I was very fortunate to have a number of internship opportunities that included judicial clerkships in Franklin County Circuit Court and Hamilton County Court of Common Pleas and a legal internship with Forethought Financial Group's compliance department.

In 2012, I started working as a Deputy Prosecuting Attorney at the Ripley County Prosecutor's Office for Prosecutor Ric Hertel. After two years, I was appointed to my current role of Chief Deputy Prosecuting Attorney. In my current position, I represent the State of Indiana in criminal cases that range anywhere from driving with a suspended license to murder and everything in between. On a daily basis, I'm assisting officers in criminal investigations, reviewing cases for potential charges, preparing legal filings, and handling hearings and trials in the courtroom.

Our role is to administer justice, so we not only ensure that those individuals who have committed crimes are being held accountable but that their constitutional rights are also being protected in the process. My position has been extremely rewarding, and I take great pride in serving a community I care very much about.

In addition, I serve on the board for Safe Passage and am a member of the Indiana Prosecuting Attorney's Association and the National District Attorney's Association.
